Confidentiality obligations on the inspection: The customer admitted to the inspection process undertakes not to disclose verbal (e.g. the content of the oral interview with the examiner and questions asked during the inspection) and written (except for the data of the received WPQR) information regarding the inspection process. Requirements for the completed WPQR: The WPQR is the property of the Customer. It is prohibited to use the certificate in a misleading manner. The received WPQR should be referenced only within the limits specified in the WPQR. It is prohibited to refer to the WPQR if the WPQR is cancelled or suspended. It is prohibited to make changes to the WPQR. The WPQR must be returned to BTI if it is suspended or cancelled by BTI. The WPQR is issued to the Customer. The WPQR can be cancelled at the request of the Customer. Compliance with the rules for using the BTI logo(s): It is prohibited to use the BTI signs and logo.
