BTI has the right to provide the EAK with the required certification information.. **Non-Disclosure obligations related to certification information:** Applicant admitted to the certification process (candidate) commit himself not to disclose to third parties verbal (i.e. discussions with examiner and questions during certification process) and written (excluding content of issued certificate) information in respect to the certification process. **Certificate requirements:** BTI maintain sole ownership of the certificate. It is forbidden to use the certificate in a misleading way. One should refer to the certificate only in a scope stated in the certificate. It is forbidden to refer to the withdrawn, suspended or outdated certificate. Any changes to the certificate are prohibited for third parties, except for 6 month qualification confirmation (EN ISO 14732 p. 5.2) Certificate shall be handed over to BTI in case it was suspended or withdrawn by BTI Certificate shall be handed over either to the Applicant, or Applicants' Employer empowered by Power of Attorney in writing. **Compliance with the rules for using the BTI logo(signs):** the use of BTI signs and logos is prohibited.
